Terms and Conditions of Sale

The present Terms and Conditions of Sale govern the contractual relationship between Retour aux Sources and any individual or legal entity wishing to make a purchase on the online store. These TCS are accessible at any time on the website.

1. Purpose

2. Products

3. Orders

4. Prices

Product prices are indicated in euros, including all taxes (TTC). The Seller reserves the right to modify its prices at any time, but products will be invoiced at the rate in effect at the time of the order.
